## Present

Meeting commenced at 6.50 pm.

There were 4 members of the public in attendance.

### 1. Apologies.

### 3. To approve as a correct record the minutes of the previous meeting held on 11.12.06 (Any amendments necessary to be received on the night).

### 4. To consider the following planning applications:

When asked for their thoughts and views the application was considered not to be a huge alteration and members felt that it was in keeping with the current house.

06/04576/FUL The erection of a permanent airfield control building (GR  
375124/120933) Land At Henstridge Airfield The Marsh Camp Road  
Henstridge Templecombe Somerset BA8 0TN. Losan Ltd.

The meeting was adjourned and members of the public given the opportunity to speak. On re-convening some members reiterated their historical opposition to development of the north side of the airfield and concerns were expressed at the scale of the proposed structure and the potential traffic movements that may be created by the building in operation. Other members appreciated that the structure had been reduced in height and accepted that although its location North of the runway was not ideal it may be favourable from the point of view of aircraft.

A proposal of approval was made. On voting the Committee were divided and as the Chair felt that the committees previous recommendation of approval on application 06/02899/FUL should prevail he used his casting vote.

A query was raised with regard to previous permissions on the site. Members recalled concerns at the size of the building and it was noted that another building on the site has been converted to a dwelling. The proposed materials were felt to be in keeping with the existing structure and there was further discussion with regard to the current and previous applications. Concerns were raised at the possibility of division of the building to create a separate dwelling in the future. The Chair encouraged members to consider the application on its own merits as it was agreed that this application if granted would overlay any existing consent.

It was proposed to recommend approval of the application with the condition that it is tied to the owners of the main house.

An amendment was proposed to add 'as an integral part of the main dwelling'.

The amendment was approved in voting.

The Chair asked members if they had any specific concerns and the need for clearance of the river Stour along its total course was mentioned. Members requested that Mrs Woods make representation concerning this, on their behalf at the meeting.
