the Henstridge Village Hall Lounge on Monday 26<sup>th</sup> November 2007.

The Chair suggested members consider both applications together and asked for member's thoughts. Concerns were expressed at the proposed location, which is highly visible from the A30 and the recreation ground, and the potential of broken glass straying onto the highway was considered. Although the front part of the building adjacent to the proposed structure was understood to be a later extension to the listed building, members still felt that the structure was not in keeping with the listed building and would be an eye sore. The proposed access was considered to be inadequate and members wondered whether the proposed structure would infringe the footpath.

**RESOLVED: It was proposed and unanimously agreed to recommend refusal of the application on the grounds that the proposed exit and entrance area is insufficient to allow for a car and HGV to pass, and this may cause potential highways safety issues on (A30). Further to this members felt that the proposed structure, which is in a highly visible location on the main approach to the village, is detrimental to the listed building in terms of location and proposed materials, and the applicant should consider an alternative site for such a structure.**
